NWRHCC Updates - Patient Tracking Pilot

Once CDPHE funds are awarded, NWRHCC will allocate funds to participating agencies. HCC role in pilot:

- Information sharing re: system implementation
- Point of contact for Patient Tracking Taskforce & participating agencies
- Attend and/or help plan MCI exercises where the Pulsara system will be utilized
 - Pulsara will provide an account for the HCC (and/or designated ESF8 Lead working at the local EOC) to have system-level visibility during exercises.
 - HCC will provide feedback to the Patient Tracking Taskforce/Pulsara for additions to the system that would make it better functioning for our partners.

NWRHCC leadership, DHSEM/CDPHE Field Managers & Integrated Preparedness Sections are collaborating to plan the 2024 Integrated Preparedness Planning process.

GOALS:


- Determine regional all-hazards training & exercise priorities for 2024-2027.
- Avoid duplication of efforts, have one source/plan for all partners.
- Help partners meet IPP/W grant requirements.
- Create a usable plan with accountability structures in place.

NWRHCC Updates - Integrated Preparedness Planning

REQUIREMENTS:

- **HCCs** are required to "participate in the Regional All-Hazards IPP Workshop (IPPW)."
- Local Public Health Agencies are required to "participate in the development or update of the Regional All-Hazards Integrated Preparedness Plan (IPP) to include four years of progressive exercise planning."
- **County Emergency Managers** that previously were part of the NWAHEMR can apply for All-Hazards grant funds if they participate.

Integrated Preparedness Planning Workshop (in-person) | April 16, 2024 - 10am-2pm

In-person meeting to determine regional All-Hazards training & exercise priorities for 2024-2027. Will be preceded by membership surveys and a "Work before the Workshop" Training for members on March 12th (see previous slides).

MRSE/CHEM Functional Exercise (in-person) | Early June, 2024

Test the NWRHCC and our members' capacity to accommodate a surge of patients equal to at least 20 percent of the region's staffed bed capacity.

Evaluate the NWRHCC members' ability to communicate critical information and coordinate to quickly place victims in appropriate facilities after a medical surge incident that overwhelms the healthcare system in the region.

Identify the support needs (i.e., SME, equipment, supplies, staff, transport, beds, space, community partners, telemedicine/telehealth, etc.) within the SRHCC to accommodate a chemical surge incident.
